1. The present petition has been filed alleging wilful disobedience of the order dated 21st July, 2026, passed by this Court in *W.P.(C) 9374/2026*, wherein, the following directions were passed:

CM APPL. 43760/2026

Exemption is granted subject to all just exceptions

The application stands disposed of



W.P.(C) 9374/2026

1. This is a writ petition filed under Article 226 of the Constitution of India seeking the following prayers: -
“c. direction to Respondent No.2 to update its website by uploading thereon the Recognition Order of the Petitioner institution and update the status of petitioner institution on its website and display its name in the list/category of recognized institutions for conducting B.ED. course with an annual intake of 200 students.
d. direction to Respondent No.2 to forward a copy of the Recognition Order of the Petitioner to its Affiliating University as well as the State Department of Higher Education, for all future references...”
2. This order is being passed in view of a similar order dated 02.02.2026 passed in W.P.(C) 1404/2026, covering the present issue. Based upon the said order and using the same reasons and expressions, this order is being passed.
3. Mr. Srivastava, learned counsel for the petitioner states that the petitioner Institute was established by the Sponsoring Trust. The recognition for conducting B.Ed course was granted *vide* order dated 04.08.2004 and this recognition was granted by the respondent No. 2 Northern Regional Committee. However, the respondents are not displaying the name of the College in the list of recognized institutions on their official website. Thus, the petitioner has approached this Court seeking to direct the respondents to update the status of the petitioner institute and display its name in the list of recognized institutions for the said course on their official website. He further points out that in the past, several orders have been passed by this Court issuing similar direction, copies of which have been filed along with the writ petition.

4. For the said reason, issue notice.
 5. Mr. Rupal, learned counsel accepts notice on behalf of the respondents and on instructions, states that the respondents have no objection to the present petition being allowed, subject to verification by the respondents.
 6. Accordingly, the petition is disposed of with a direction to the respondents to verify the status of the petitioner institute and if upon verification the same is found to be a recognized institute, the respondents shall update the status on the website in the list of recognized institutions within one week. Thereafter, communication to this effect shall be sent to the affiliating body as well as Department of Higher Education, Government of Uttar Pradesh, within a period of one week from the date the status is uploaded.
2. Learned counsel appearing for the respondents has handed over to this Court a copy of a document to show that after verification, the status of the petitioner herein, has been updated on the website of National Council of Teacher Education (“NCTE”), in the list of recognised institution.
3. The said document is reproduced as under:

4. *Per contra*, learned counsel appearing for the petitioner submits that the status as updated on the website of NCTE, reflects that the petitioner-institution is recognised for a total annual intake of 100 seats. However, he submits that the petitioner institute is recognised for a total annual intake of

200 seats.

5. Perusal of the document reproduced as aforesaid, clearly shows that at serial no. 3, the petitioner herein was granted revised recognition for an intake of 200 seats *vide* order dated 05th June, 2015, passed by the NCTE, Northern Regional Committee. Subsequently, 100 seats were withdrawn *vide* order dated 31st May, 2025, passed by the said committee.

6. However, pursuant to the order dated 15th December, 2025, passed by this Court in *W.P.(C) 9343/2025*, the said 100 seats were restored by NCTE, Northern Regional Committee.

7. Thus, it is evident that 100 seats which had earlier been withdrawn out of the 200 seats, were accordingly restored in terms of the order dated 15th December, 2025 passed by this Court.

8. Accordingly, it is apparent that the petitioner has been recognised for total annual intake of 200 seats.

9. This Court also takes note of the letter dated 11th August, 2026, issued by the NCTE, which is reproduced as under:

NCTE and amr. it is to inform that the institution "RSS Degree College, Saidpur, Baldeo Mathura, District-Mathura, State- Uttar Pradesh is recognized for B.Ed. Course. As per official records the status of the respective course are as under.

1. 3. The institution is recognized for B.Ed. two years duration till date.
