1. The accused/applicant seeks regular bail in case FIR No. 360/2024 of PS Alipur for offence under Section 394/397/411/34 IPC.
2. Status report has not been filed by prosecution. It appears that prosecution has no serious objection to this bail application.
3. Broadly speaking, the allegation against the accused/applicant is that on 21.05.2024, with the help of his co-accused, the accused/applicant committed robbery of a mobile phone of the complainant *de facto* and in the

process, the co-accused inflicted a stab wound on the right leg of the complainant *de facto*, after which both accused persons fled the spot.

4. Learned counsel for accused/applicant submits that the co-accused who had allegedly inflicted stab injury on the leg of the complainant *de facto* has already been granted bail by the trial court way back on 08.10.2024 while the present accused/applicant remains in jail.

5. Learned APP assisted by Investigating Officer/ASI Satyaveer opposes the bail application on the ground that TIP pertaining to the accused/applicant was successful. It is also submitted that the accused/applicant is involved in three more cases, though he is on bail in all those cases.

6. Admittedly, the injured complainant *de facto* was discharged from the hospital on the same day. Rather, the MLC of the complainant *de facto* reflects that he was found with smell of alcohol in his breath. The co-accused who allegedly inflicted the stab wound on leg of the complainant *de facto* has already been granted bail. The accused/applicant cannot be kept in jail endlessly. As regards the TIP, the accused/applicant was arrested on 22.05.2024 and sent to judicial custody, after which it is on 28.05.2024 that TIP was conducted.

7. Considering the above circumstances, I do not find any reason to

deprive further liberty to the accused/applicant. Therefore, the bail application is allowed and accused/applicant is directed to be released on bail subject to his furnishing a personal bond in the sum of Rs.10,000/- with one surety in the like amount to the satisfaction of the Trial Court. The accompanying application stands disposed of.
